



## Initial Program Completer Data: AY 2024-2025

Collection: Data on initial certification candidates is collected regularly as part of Alabama State Department of Education requirements for certification. The data in this report includes total Praxis II and Pearson Foundations of Reading 190 scores (content knowledge) and edTPA scores (content and pedagogical content knowledge) for all program completers who graduated in academic year 2024-2025 at both the bachelor's and alternative master's levels.

Instruments: Both Praxis II, Foundations of Reading 190, and edTPA are externally created and validated assessments with ETS and Pearson respectively.
